Dear Danielle Heable,

I am following up on a consultation I had with you on 24th June 2016 in which you met with me on behalf of Chris Hannay of Hannay Lawyers.

At that time I had brought to your attention matters of grave concern regarding cover-ups and corruption within the greyhound racing industry, and in particular the false inquiry in which I was framed by the Queensland Greyhound Racing Authority (now reformed as Racing Queensland) and the baseless litigation against me by the Chiropractors Board of Queensland (now reformed as the Chiropractors Board of Australia | AHPRA).

During my meeting with you we first established that there would be no conflict of interest as the information and evidence I was putting on the table was against the board of Racing Queensland, not the clients involved in racing who you represented at the time.

I provided you with detailed information including a USB drive containing a copy of the evidence that was provided to Sir Peter Cosgrove some months earlier in February of 2016. The information I provided to you gave a comprehensive overview of the history of events until that time. This was further to the approximately 20 minute explanation I provided directly to you during our meeting in June 2016.

You assured me that you would review the information and make contact with me again to arrange further discussion on how to proceed.

It's been 7 years since then and I have not received any word from yourself or from Hannay Lawyers. You stayed on with Hannay Lawyers for a further year until May of 2017 after meeting with me, and I would have thought that I should have received some form of contact or advice from you within at least that time frame.

Most disappointing was when I discovered that without my knowledge or consent, information I provided to you was used as leverage in favour of one of your clients, Tom Noble. This is a most concerning breach of privacy and not at all what the information I provided to you was intended for.

Obviously I am deeply disappointed at having not received word from you or your office at the time, and I require an explanation. I was homeless at the time having been forced out of residence in fear of my life being under threat due to the seriousness of the corruption I was exposing and the threat it posed to the racing board. Had the matters I was raising been properly addressed with the proper action taken to initiate an investigation and legal proceedings, then I surely would not have had to continue to sustain the incredible damages to my life and business such as:

- Being ostracized from having legal representation by retired Chief Justice Wayne Martin of Western Australia threatening anyone in the legal profession willing to take on my case or handle my evidence with disbarment
- Controlled opposition moles having been planted into my life in order to deliberately delay submission of or destroy my evidence, and sabotage my case
- Being subjected to death threats, assault, being knocked unconscious and hospitalised, held at gunpoint, falsely accused, and being publicly defamed and humiliated with my businesses and livelihood destroyed beyond repair (most recently I have been harassed in public by an assailant driving a vehicle with stolen plates ramming my car multiple times)
- My training license being revoked on a fraudulent basis, causing me massive loss of income through business revenue and prize money from race meetings in which I would otherwise have been able to participate
- The destruction of my professional reputation and having lost countless clients resulting in loss of income worth hundreds of thousands of dollars annually, all while suffering several attempts on my life, as well as the deliberate sabotage and destruction of my possessions, vehicles, and properties

I'm sick of the lies and misleading that goes on in the legal and law enforcement system that are supposed to be upholding the law. As you are aware I document and record all interactions and correspondence having been tipped off from up high to do so, so that I can always refer back to the truth of what transpired. With no support from lawyers, police and law enforcement, judges and the courts, I made the decision to produce my own media and video content to show the truth of events to the public and garner their support.

Without such incredibly prolonged delay in legal proceedings as what I have been forced to sustain, then I may not have had to also sustain the tremendous damages to my life and business that has resulted from this delay.

In the interest of Natural Justice and The Public, I would appreciate if you would provide me with a reasonable explanation as to why you failed to contact me regarding the matters mentioned above after our meeting in 2016.

I also demand the immediate return of the evidence I provided you in 2016.
