Dear Mr David Crisafulli,

I am following up on a correspondence submission which was hand delivered by members of my organisation, the Phoenix Taskforce, on 18th July 2023 to your office at Hope Island Central, 340 Hope Island Road, Hope Island.

The submission was in regards to cover-ups and corruption stemming from within the greyhound racing industry and reaching all the way up through to the highest levels of government - a matter of great concern to the public as shown in the notably sizeable binder of petitions also submitted on the 18th.

I was most disappointed in the lack of willingness by your office to sign for the delivery. The suggestion by your office that the delivery be posted was redundant. My team members were standing in your office with the delivery ready to hand over there and then. What purpose would it serve to post it aside from making it more easy and likely for it to be blocked or "go missing"? This has happened dozens of times in the past when I have attempted to mail such information hence why I have no other option but to have documents hand delivered.

It is my understanding that as a member of parliament you are in service to the public, and as I am bringing matters of public interest to your attention I would expect that any correspondence or documentation related to such matters would be gracefully received. But this was not the case. Having reached out to me previously to offer your support in my work of uncovering cover-ups and corruption in the greyhound racing industry, I would have thought such a delivery would be expected and willingly accepted. As leader of the opposition and servants of the public, the fact that my team was met with complete unwillingness by your administration to sign for the delivery shines a very unfavourable light upon you and your office.

Unfortunately, having been up against such tremendous apathy in the past with repeated instances of my document deliveries being met with redirection, having supposedly gone missing, or no response whatsoever, I have had no recourse but to have these deliveries performed by hand and documented on video.

Had this matter actually been treated seriously by the offices of other MPs, regulatory and government agencies, and law enforcement, with the proper action taken to initiate an investigation, then I surely would not have had to continue to sustain the incredible damages to my life and business such as:

- Being ostracized from having legal representation by retired Chief Justice Wayne Martin of Western Australia threatening anyone in the legal profession willing to take on my case or handle my evidence with disbarment
- Controlled opposition moles having been planted into my life in order to deliberately delay submission of or destroy my evidence, and sabotage my case
- Being subjected to death threats, assault, being knocked unconscious and hospitalised, held at gunpoint, falsely accused, and being publicly defamed and humiliated with my businesses and livelihood destroyed beyond repair (most recently I have been harassed in public by an assailant driving a vehicle with stolen plates ramming my car multiple times)
- My training license being revoked on a fraudulent basis, causing me massive loss of income through business revenue and prize money from race meetings in which I would otherwise have been able to participate
- The destruction of my professional reputation and having lost countless clients resulting in loss of income worth hundreds of thousands of dollars annually, all while suffering several attempts on my life, as well as the deliberate sabotage and destruction of my possessions, vehicles, and properties

The documents I have delivered to your office contain an extraordinary amount of incriminating evidence to both prove the legitimacy of this matter, as well as provide your administration with a solid foundation from which to launch an investigation.

To assist in such action, included with the correspondence delivery last week on the 18th, I have provided you with a comprehensive and detailed video breakdown of the key events that instigated this campaign against systemic corruption, namely the QGRA (Queensland Greyhound Racing Authority – now Racing Queensland) false inquiry in which I was framed, as well as the orchestrated Chiropractors Board Of Queensland (now Chiropractors Board Of Australia | AHPRA) law suit that preceded it.

Both of these attacks were intended to silence me from exposing and revealing to the public the corruption of officials, stewards, and other members on the board of Racing Queensland concealing their illegal greyhound ownership and participation in race rigging/fixing, and a whole lot more. Their tactic was to thoroughly defame me resulting in the destruction of my thriving business and professional reputation. You will find both digital and hard copy evidence dossiers as well as full transcripts of the false inquiry hearings to accompany the following videos which were provided on USB drive along with the delivery to your office last week on the 18th:

- Pandora's Box Is NOW WIDE OPEN
- False Inquiry Breakdown – Part 1
- False Inquiry Breakdown – Part 2

With no support from lawyers, police and law enforcement, judges and the courts, I made the decision to produce my own media and video content to show the truth of events to the public and garner their support.

Digital evidence of the thwarting of my defamation lawsuit against the Chiropractors Board and associated records of Supreme Court proceedings have also been provided on the above mentioned USB, as well as the full evidence package previously submitted to Governor General Sir Peter Cosgrove in 2016.

With the sheer scope of such systemic corruption, the staggering amount of incriminating evidence I have provided, and given that no other regulatory, law enforcement, or government body has been willing to take action, one would surely think that such a matter would be a significantly high priority on your agenda.

In the interest of Natural Justice and the public, I would appreciate if you would provide me with an update on the progress of my correspondence delivery on the 18th of July 2023. Has the correspondence actually reached your office desk? As stated in the cover letter delivered, this was an Urgent Call For Support to which evidence of action being taken was to be provided by Tuesday 1st August (14 days from the date of delivery).
