URGENT DEMAND FOR INTERCESSION – FINAL NOTICE

Dear Mrs Grace Grace

I am contacting you for the final time regarding a highly urgent matter in the name of natural justice and in serving of the public interest. The matter is in regards to cover-ups and corruption stemming from within the greyhound racing industry and reaching all the way up through to the highest levels of government, a matter of great concern to the public as shown in the notably sizeable binder of petitions I am providing along with this correspondence. As well as a significant show of public interest I am also providing you with a strikingly large body of evidence to comprehensively prove that the matter I am raising with you is both legitimate and of a gravely serious nature.

More specifically this matter regards greyhound racing board stewards, officials, and other members of the board routinely concealing their illegal ownership of greyhounds under false names, their direct involvement in widespread race rigging, their complicity in live animal baiting and the killing of greyhounds, and the cross-industry as well as government collusion in covering it all up and attempting to silence me from exposing it.

I have it on good authority that you Mrs Grace have taken up the role of Minister for Racing with the intent and resolve to be the first minister in decades to effectively clean up the racing industry of all corruption, fraud, animal cruelty, and other criminal activity prevalent within the industry.

Over the past fifteen years I have exhausted every established conventional route and official channel for submitting my evidence, distributing crucial supporting documentation to not only the CCC, but also to every relevant government office and regulatory body in Australia including the Queensland Racing Integrity Commission, the Australian Police Service and Senators in almost every state including your own office after the commencement of your tenure as a Member of Parliament in 2015, the Attorney General's office, and even the office of the Governor General. In each instance I have prompted urgent investigation into these matters but each and every time I have either been ignored, given the run-around, had my evidence returned to me, or have been told that the evidence was too far reaching and could not be viewed lest it open Pandora's box. Most disappointing was my evidence submission to Hon Stirling Hinchcliffe in January of 2016 to which I have received no response and which Mr Hinchcliffe took no action on even after taking office for his term as the Queensland Minister for Racing.

Should this submission result in the same outcome, know that delivery of this submission has also been documented on video, and will most assuredly make its way into the arena of the Australian public. To this end I have arranged for this letter and submission of evidence to be hand delivered to your office having also just delivered the very same body of evidence to Canberra as well as the opposition; the offices of David Crisafulli MP, in readiness for any further blocks that may occur with getting action taken on the evidence I am now delivering into your hands. I am left with no other option but to deal with matters in this fashion as I am afforded no assistance or protection by police and law enforcement.

During the Alan MacSporran Queensland Greyhound Racing Commission of Inquiry in 2015 I submitted evidence directly to the commission, as well as having evidence delivered through a back door contact, Matt Lever, a law student at the time and friend of Jen O'Farrell who was heading up the commission. However, the submission was blocked after retired Chief Justice Judge Wayne Martin threatened disbarment to any lawyer willing to view my evidence. The advice of Jen that I received back from Matt who's eligibility to pass the bar was also under threat, was to spread my evidence and story far and wide to every mainstream media and news outlet, but this yielded the same ineffective result.

I attempted to bring these matters of corruption to the attention of Jarrod Bleijie during his tenure as Attorney General in 2013, having delivered a comprehensive body of evidence to both of his offices at the time in Maroochydore and the State Law building in Brisbane. During the inquiry, I also hand delivered copies of evidence to the Office of Racing who assured me they would pass on the evidence to Jarrod. However, the evidence was returned to me, and despite serving multiple subsequent Show Cause notices on Jarrod's offices nothing had been done. After Yvette D'Ath had taken office as Attorney General I went through the entire process again only to receive a paltry response advising that I should seek private legal advice for what had been deemed a private dispute. This is NOT a private dispute.

The scope of these matters goes beyond the legal battles I myself have fought and the suffering I have personally sustained, falling well within the public interest, because they implicate perpetrators involved in corruption affecting the greyhound racing industry as a whole, as well as exposing the cross-industry and government collusion in covering it all up. I am not the only member of the greyhound racing community who has suffered at the hands of Racing Queensland. The public is fed up with these matters having not been addressed as evidenced in the petitions which I am supplying to you in both digital and hard copy format along with this letter.

ALL of the government and other organisations directly responsible for taking action on this evidence have failed in their Duty of Care, and professional capacity to report or act on a known and orchestrated injustice, which affects not just myself, but also the Australian public and the animal kingdom. My ongoing petition to request a Royal Commission into the corruption within Racing Queensland as well as into Queensland Government and regulatory bodies as to why my evidence has not been investigated and all guilty parties involved have not been dealt with according to the Law, clearly

shows that these matters are well within the public interest as the petition continues to garner support reaching new eyes daily.

During the time I have been attempting to have my evidence acted upon, the only actions that I have seen were from individuals and organisations who found my evidence and I too big of a threat.

As stated above I was ostracized from having legal representation by retired Chief Justice Wayne Martin of Western Australia threatening anyone in the legal profession willing to take on my case or handle my evidence with disbarment.

Controlled opposition moles have been planted into my life in order to deliberately delay submission of or destroy my evidence, and sabotage my case.

In a most heinous form of intimidation I have had twenty-five of my animals poisoned and killed with the recent poisoning of one of my cats in January of this year, all of which I have also supplied evidence of on the USB drive being provided with this cover letter.

I have been threatened, assaulted, knocked unconscious and hospitalised, held at gunpoint, falsely accused, and publicly defamed and humiliated with my businesses and livelihood destroyed beyond repair. Most recently I have been harassed in public in May this year by an assailant driving a vehicle with stolen plates ramming my car multiple times.

My training license has been revoked on a fraudulent basis, causing me massive loss of income through business revenue and prize money from race meetings in which I would otherwise have been able to participate.

During these difficult years fighting to clear my name and have my evidence investigated, due to the destruction of my professional reputation I have lost countless clients resulting in loss of income worth hundreds of thousands of dollars annually, all while suffering several attempts on my life, as well as the deliberate sabotage and destruction of my possessions, vehicles, and properties.

If Kerry Watson (ex-GRA Chair) and her syndicate of board stewards (now Racing Queensland) had not colluded with the Chiropractors Board of Queensland (now Chiropractors Board of Australia | AHPRA) in staging baseless litigation and fraudulent inquiries against me to prevent me from exposing the corruption of the industry, then my businesses would still be thriving, and I would not have had to sustain such tremendous personal, professional, and financial loss as a result of these strategic attacks.

For more than 15 years I have vehemently been seeking:

- The exposing and discontinuation of all live animal baiting as well as the killing and disposal of greyhounds
- The exposing of officials, stewards, and other members on the board of Racing Queensland participating in illegal greyhound ownership and race fixing
- Investigation into the Racing Queensland connections colluding in covering up all of the above
- To have my name publicly cleared of all wrong-doing with a public apology from Racing Queensland and the Labor government
- That all perpetrators be held fully accountable and prosecuted

- Compensation for the unmitigated losses I have sustained
- The reinstating of my public trainer and studmaster/breeder licensing

I seek your assistance now in pursuing the delivery of all of these outcomes as no other regulatory, law enforcement, or government body has been willing to take any action on these matters for which they are otherwise directly responsible for seeing meet justice.

Once these matters were put into the hands of the government and in particular those of Hon Stirling Hinchcliffe, that should have been the end of the attacks directed upon me which I have summarized above, but instead it turned out they had only just begun and continue today. The latest recorded incident of intimidation and harassment aimed at me can be seen both online at my website <https://phoenixtaskforce.org> and within the Phoenix Taskforce Video Library found on the USB drive provided with this letter, in the video titled “*Hit & Run*” where my car was rammed by an assailant driving a car with stolen rego plates. Unfortunately these kinds of attacks have become commonplace.

How terrible it is that I have had to establish and fund my own media production crew to create online content in order to expose this mess. With no support from lawyers, police and law enforcement, judges and the courts, I made the decision to produce my own media and video content to show the truth of events to the public and garner their support.

I have been supremely patient, but now I have no patience left and I have nothing left to lose. After more than 15 years of struggle, busting my guts for the animals and the public, it’s time this mess was cleaned up, and the greyhound racing industry was reformed from the ground up for the betterment of all. Yet again in the pursuit of justice I am forced to displace my animal chiropractic work and primary income in order to compile and collate evidence for this submission.

With all due respect Mrs Grace, due to government apathy I have suffered tremendous damage to my life and business for decades for the sake of standing in the truth, and I have let things go on for quite long enough. Thus, having exhausted all other avenues and with nowhere else to turn, I demand your intercession and immediate action as Minister for Racing overseeing the regulatory and government bodies responsible for addressing such matters and who failed to act, to commence investigation into the cover-ups and corruption of Racing Queensland and its connections. To assist in this action I am providing you with a comprehensive and detailed video breakdown of the key events that instigated my campaign against systemic corruption, namely the QGRA (Queensland Greyhound Racing Authority – now Racing Queensland) false inquiry in which I was framed, as well as the orchestrated Chiropractors Board Of Queensland (now Chiropractors Board Of Australia | AHPRA) law suit that preceded it, both of which were intended to thoroughly defame me resulting in the destruction of my thriving business and professional reputation. You will find both digital and hard copy evidence dossiers as well as full transcripts of the false inquiry hearings to accompany these videos which are also being released on the internet:

Digital evidence of the thwarting of my defamation lawsuit against the Chiropractors Board and associated records of Supreme Court proceedings have also been provided, as well as the full evidence package previously submitted to Governor General Sir Peter Cosgrove in 2016.

To highlight the seriousness of this issue I am also providing samples of news and articles showing that this matter is of national scope and current in the awareness of the Australian public.

You are now on FINAL NOTICE to launch a full scale investigation into the fraud, misconduct, cover-ups, and corruption within Racing Queensland and their connections. After a lifetime of struggle I am supremely resolute in seeing justice served and to this end I will not relent.

If you resolve to take action on this I request that you produce evidence in the form of a public media release indicating that investigation into this matter has been initiated within 14 days of receipt of this submission.

In the interest of Natural Justice and in both public and animal welfare I anticipate your prompt response.
