I am writing to you as a last resort and in desperation for action, a full enquiry or a Royal Commission into the corruption within Racing Queensland, the Chiropractic Board of Australia, and their Government connections.

I have exhausted every avenue to get help, and have received no reasonable response or help from anyone.

I have been gathering evidence since 1994 regarding the Greyhound Debacle at Darwin Greyhound Racing Track, where I lived and worked as a Caretaker, doing maintenance, driving the lure for the Public Greyhound Trainers & other owners and Trainers, and general maintenance. While I was there I became aware of a terrible stench on investigation I found a type of gravesite where they were shooting the slow & unwanted Greyhounds and then burning the carcasses, this was a common occurrence and I was horrified and appalled at this discovery and that it was an accepted practice, and well known of. (Document attached from Mark Pink President of Darwin Greyhound Racing with witness to my honesty & integrity.)

In early 1999 I called a meeting with Danny Ryan (Chief Steward) and Peter Cork (Chairperson) at Albion Park Greyhound head office to discuss what I knew about animal blooding and unwanted and slow Greyhounds being shot also to complain about actions of Kerry Watson who was a member of the owners and trainers committee at that time.

After Danny Ryan talked privately to Peter Cork in his office he asked me what do I want out it, my reply was that I only wanted to stop the animals being blooded and killed and for the sport to be cleaned up in house, I was not trying to damage the Greyhound Industry I only wanted it to be clean and stop the torture of the innocent animals.

I have been an Animal Healer and Animal Chiropractor for over 30 years and have worked all over Australia and my job, heart and soul is to heal the animals not to stand by and watch or know of animals being blatantly tortured and killed.

Their reply was that they would look into the blooding of Animals and the Greyhounds being shot. Nothing was ever done and seemed to be totally ignored and covered up. In late 1999 Danny Ryan came to my place at Old Cleveland Rd, Capalaba and I told him about Vic Sorens have a breaking in and education Centre for Greyhounds that was using possums, cats, pigs, & chooks for blooding and also shooting an enormous amount of Greyhounds and burning their carcasses weekly. I also told Danny Ryan that I knew

about Rodney Potter (Chief Steward for the racing authority in NSW that was involved in race rigging, corruption, taking bribes and etc. I also mentioned that I knew that it was happening in Queensland as well by the board Stewards. Danny Ryan also had his own dogs being trained by trainers under another name, Stewards were racing dogs under other names, race rigging, moving starting boxes to advantage the NO 8 dog, dogs being got at in the kennel complex on race day. It was also happening to my dogs for years. Now I have more knowledge I understand the reason why nothing was ever done as the likes of Danny Ryan and other Board Stewards were having their own dogs educated there and other complexes everywhere and it was not in their best interest to bring these organizations out into the public eye.

5 Cases of fine cotton in the Greyhound Industry in Queensland, the owner/trainer came forward and gave me the evidence,

- In November 2014 I have had another greyhound poisoned and another greyhound blinded by some chemicals being sprayed into their eyes, (this is the 2<sup>nd</sup> greyhound blinded) previously I have had over 18 greyhounds, 1 guard dog and 1 cat poisoned to try to silence me. I have also had equipment damaged and a vehicle stolen, and over \$100,000 taken fraudulently from my bank account. (Copies of Transactions and supporting evidence included)
- I was shot at in about 2000 by a high powered rifle on Darwin Greyhound track, police doing a breath test on the highway heard the shot and responded, therefore there will be a report in Darwin. In 2008 I had a hand gun pulled on me in Gympie on my property, the gun misfired and I was then hit over the head with an iron bar, I was unconscious for several hours in the yard. I have also had guns pointed at me while driving with a witness in the car and people trying to ambush me. I have video evidence to support this.
- On 1<sup>st</sup> Dec 2003 (doc enclosed) the Chiropractors Board of Queensland now (Chiropractic Board of Australia) sent a letter regarding using the word Chiropractor, it was signed by Debby Ramsay Assistant Registrar. I discussed this letter with a Dr Mark Pickford (Human Chiropractor) that I referred my client's human owners to when they inquired about Chiropractic care for themselves. He knew of the debacle with Kerry Watson and her board and told me not to worry, giving me legal advice on how to handle it, and that he would fix it, and I was led to believe that he was a Lawyer as well as a Chiropractor. He was well aware of my treating only animals and advised me that any future advertising should contain the word animals. He reiterated again that as he was on the board and I would hear no more about it, but he neglected to inform me that he was the Chairperson at that time it all started. I have only just found this out this on the 11 Dec 2015.
- The Chiropractic Board went away until 9<sup>th</sup> August 2005 when I received a letter regarding a so called breach of the same nature of their legalities (document enclosed). This was also signed by Debby Ramsay Assistant Registrar.
- In August 2005 I met Rachel Ann-Marie Thomson when she bought her pet Chihuahua to me to treat. Rachel was a part of this set up, she started out wanting to help me with my Greyhounds and after I began to trust her we then became involved in a relationship. When she won my complete trust she was able to access letters that she burnt thinking it was my only evidence against Kerry Watson and the stewards of Greyhound racing Queensland. Unknown to me at the time, Rachel's mum Jocelyn Thompson was best friends for over 25 years with Kerry Watson. During our relationship Rachel reveled information about the sexual abuse from her dad Peter Thomson (ex NSW Police force, stationed at Parramatta, sacked for corruption) and the pedophilia on his computer. A raid was organized because Rachel rang and made a formal complaint against Peter Thomson however Peter had a friend in the police force at LoganHome (Police Sergeant) and he was warned about the upcoming raid.
- Kerry Watson also came back into my life in August 2005 at the Ekka where she was interfering with the judging of Dogs, I had been awarded 1<sup>st</sup> place and she then overruled it, by calling out to the judge from the sideline "No No that is Doc Jamieson", "No No that is Doc Jamieson "she was standing with Kirsty O'Brien (who was in charge of the rehoming of Greyhounds program called The

Gap, Kerry Watson was Kirsty O'Brien's boss) and I was pulled out of 1<sup>st</sup> place and put into 2<sup>nd</sup> place. I have never shown a dog since then as it was obviously full of corruption. I have attached a statement from Kirsty Obrien admitting foul play from Kerry Watson.

- In 2006 Chief Steward Danny Ryan and investigating officer Darryl Kay came to my property at Willowvale and told me that Kerry Watson (she was a chairperson using her position as a tool) had been to the Chiropractic Board Of Queensland in 2005 to instigate them to open an inquiry against me. In 2007 as I was going to court to defend my name against the Chiropractic Board, Greyhound Racing Queensland (Kerry Watson) also opened up a false inquiry against me at the same time. Kerry Watson was at the courthouse on that day trying to defame my name and character. She was doing this to me for a favor to the Thomson's, and the Racing Board and because I knew about the inside corruption and collusion and dark side behind closed doors within the Greyhound industry, and the Pedophilia . I already knew about her trying to set me up hence my voicemail (attached) she had the opportunity then to stop all of this but she did not, they then came in harder at me.
- Danny Ryan was giving me evidence about Kerry Watson and was later found dead, Sue Burleigh
  was also ready to come forward and give me evidence about Kerry Watson, she was also found
  dead. Strange she was ready to give up Kerry Watson and the Racing board, I was told by Ned Snow
  that she was having drinks with Kerry Watson the night before she was found dead. (I also have
  audio evidence of this)
- On April 16 2007 the Chiropractic Board of Queensland posted a <u>false</u> Statement stating I was found guilty of contravening the Chiropractors Registration Act 2001 (document attached) This statement was left on their main media release website for approx. 20 months. So therefore when you google Animal Chiropractor or Jamieson the statement Re John Jamieson would come up.
- On 4<sup>th</sup> May 2007 the Queensland Justices Act, a decision was handed down by Judge Margaret White stating that I was found not guilty on all charges of prosecution (document attached)
- In May 2007 I was set up by Kerry Watson, Danny Ryan, John Doss, chief Steward in Bundaberg, Bill & Narelle, (people that shot the 55 Greyhounds in Bundaberg last year) and other board Stewards were involved in the false set up against me because I knew about the dark side of Greyhound Racing in Queensland. I had mentioned that I was going to go to the CMC and the Attorney General, and Danny Ryan laughed stating that they had contacts in the CMC and that the then Attorney General was on their payroll. I then said that I would go to the previous Governor General and their reply was that they have contacts everywhere, including there as well. Please do not think that I am disputing your integrity or honesty as you were not in office at the time.(audio tape attached)
- An appalling apology regarding the statement on their main media release website was sent out and posted very briefly on their website but it was never signed or dated and the False statement was still alive on the website until 2014, <u>EVEN</u> after the Supreme Court Judges ordered and ruled it to be removed in 2010, it was downloaded and certified by lawyer Paul Donnelly and John Walsh ( A magistrate judge from Norfolk Island,) who was my legal representative for the day for respect to the courts as no barristers or lawyers would act on my behalf for fear of being black banned. Even today they are still too afraid or will not to act on my behalf. (please find attached relevant document Re Chiropractor Board Of Qld v Jamieson Claim for Compensation for damages)
- In 2008 I sought legal advice to go back and sue the Queensland Chiropractic Board for Defamation relating to the False statement, My legal Adviser at the time was Peter Boyce from Maroochydore, he gave me misleading advice, advising me that it was a Civil matter where it should have been a Criminal Defamation Case because of the intent to damage and destroy me, my name and business reputation and my life. He also stated that I had to get an extension of time to go back to sue for compensation but that was not true, I was still within my time frame. I lost the case on bad advice but on having him investigated he was found to be corrupt and had to refund me some money. I then had to go back and appeal the decision in the Supreme Court of Queensland. I was asking for documents to substantiate my case and a report of the many hits on the website, also documents regarding Kerry Watson and the Thomson's going to the board in 2005 putting in false complaints.

The Queensland Chiropractic Board closed and all their documents etc. were very conveniently or inadvertently lost as they told the Marrochodore Judge that day. They handed over a report of 700 hits on the website at the last minute before I was going back to court to get a court order, I found an error in the law that enabled me to then win my case to go back and sue them for compensation.

- On 20/9/2013 my doctor Dr Lynn Freeman provided a statement showing that the defamatory document or false statement was still on the website, she printed it in her office and signed and certified it and I witnessed it.
- On 22/7/2014 Katherine Learmonth also printed a copy of the False Statement and signed and certified it, showing that the document was still alive on the website, after the Chiropractic Board had been <u>ordered and ruled</u> by the Supreme Court to remove it.
- During the previous 7 years I had contacted the Chiropractic Board on numerous occasions to ask them to remove the statement as it was doing untold damage to my name, my business, and my life, nothing was ever done and I had to start posting the Non Conviction notice and proof of evidence to support my innocence and keep my business alive.
- In March 2014 I had been hospitalized due to being attacked/ ambushed, this was never investigated by the Police Sergeant Mark? At Harrisville. That turned up at the scene that night. This was the 4th attack on my person, Darwin, Gympie, Loganholme and Harrisville. Previously I have had numerous death threats and attempts to silence me. There was a staged breakdown out the front of my gate that was a set up to try to ambush me at Willowbank. I was informed by my neighbor that they were staking the property out the day before, I have video & audio evidence to support this.
- People have been placed in my life to get close to me and destroy me, and take me and my evidence down from the inside and to silence me.
- My animal chiropractic business has been closed down for over 12 months now because of all the misleading and corruption, collusion, fraudulent acts that have been covered up. These have taken place within my surroundings and around my life. This has not been dealt with or looked into even for my safety or as a duty of care of an Australian Citizen.
- I have since opened a new business of Animal Crimestopping Rescue to help the animals and rebuild my reputation in business and try to get my life back and get back to doing what I was meant to do, help the animals, not fighting legal battles.
- I spoke to Hayley Cotton from Animals liberation in Queensland just prior to them going to air in February 2015 telling her that I have just about got the Ringleaders of the Corruption and all the names of the Greyhound Blooders and shooters from all over Australia. I was explaining to her that when we caught these Ringleaders that they would have their contacts in their diary, phones and computers because they are the controlling bodies and then we would get the lot, and clean up the whole Greyhound industry for the betterment of Greyhound Racing and the public. Why did they not wait for my evidence or even ask me about the names that I had so far, who were they protecting? On the 3/2/2016 I had just found out about a rally at Brisbane to shut down the Logan Greyhound Racing track, I was not informed or even told about this from Hayley Cotton from Animal Liberation Queensland. I have audio evidence of these conversations. How can we shut down a track when the only Shareholder is Queensland Government?
- A lot of bad people in power in Queensland Government and Racing Queensland were going to try to steal Millions of Dollars from our Queensland Government with the new Greyhound Track at Logan Cronulla Park and a lot more I know about, such as Kerry Watson had a lot of contacts in the Logan Council that she was colluding with to get things passed through. We stopped that from happening because we spread the word about what they were trying to do. So there is a lot of people in the Queensland Government and Racing Queensland that are not happy with me and would like to see me dead. I came under attack from the Councils of Ipswich, Gympie, Logan and

Brisbane, they all had contacts within the Greyhound Racing Queensland and Kerry Watsons department. Where ever I moved to the council was against me being there.

- In December 2015 I had an email from Trent Anthony one of the good Greyhound Trainers from Tasmania asking me to please come to Tasmania and help clean up their Greyhound Racing Industry as well as it is full of corruption. (Letter attached) this shows that the corruption is still active and needs help to get it clean and cleared up, for the betterment of Greyhound Racing.
- The main stream media was also issued with all the evidence of my case on numerous occasions, as recently as December 2015, this evidence was lost, misplaced or covered up and not dealt with at all.
- To my disappointment I have also sent letters to Tony Abbot/ Annastacia Palaszczuk describing my situation and providing information of proof of evidence of corruption and conspiracy that I have in my possession, and copies spread around Australia. I have heard nothing from either of their departments, no correspondence at all. There has been huge lack of duty of care to this situation. It appears to me that whilst I am concerned about holding up the enforcement of justice, the people whom are currently working for the cause of justice have shown me nothing more than a lack of interest and cover ups, making way for more corruption and dishonesty to play a major role and take over our society.
- I have exhausted every possible avenue and have evidence to confirm this.

This saga and a lot of the relevant information of the truth have been seen by over 39000 people on Facebook. My Facebook page has been shut down on numerous occasions and Facebook have taken money unauthorized from my account.

I feel that this has become a personal vendetta against me and I am shut down at every turn and no one is willing to help, lots of people wanting to kill me or silence me but no one wanting to help. This is attempted murder, shot at, knocked unconscious 4 times. I have had threats, been intimidated, constantly under surveillance, my electronic equipment continually being hacked to stop me, but where is the help.

I have so much more evidence and supporting evidence, videos, transcripts, audios and supporting documents that it goes on forever. I have kept every single piece of evidence for my own safety and to protect myself. I have the evidence spread far and wide in Australia again to protect my life.

I have requested help and submitted evidence for my case asking for assistance to the following organizations, and people over the past 21 years

Supreme Court of Queensland Case no 4593 of 2010 David & Goliath (John Jamieson v Chiropractic board of Australia)

- 1. Petrie Police, not interested too big.
- 2. Tony Fitzgerald (I have sent him 3 letters and evidence in support of the conspiracy)
- 3. Custom Intel Australia Canberra
- Racing Commission of Queensland NO INTEREST (was given evidence of the Greyhound Blooding & Corruption in 2013 while the investigation on Bob Bently while they were calling for submissions.)
- Office of Racing, John Patterson was tipped off 3 months before I was set up, it could have all been stopped but wasn't. I sent him a SHOW CAUSE NOTICE in August but no reply.

- 6. Lawyers in Queensland
- 7. Courts in Queensland
- 8. Supreme court of Queensland
- Peter Boyce Lawyer( currently a board member of Racing Queensland) of Butler McDermott (misled me and then I found out he was a board member of Racing Queensland.(Conflict of interest)
- **10.** High court of Australia, their reply was that they had sent all correspondence to the Supreme Court of Queensland.
- 11. Racing Commission of NSW (see John Kaye Greens MP)
- 12. John Kaye Greens MP NSW (was actually investigating the inquiry into corruption of Greyhound racing in NSW and he should have sent the evidence to the Racing Commission of NSW who were calling for submissions, instead he just sent the evidence back without looking into it. Maybe he thought it would open Pandora's Box and too big to deal with.) I have audio evidence to support this.
- 13. Show Cause Notice -Attorney General Office, to Jarrod Bleijie, in 2013, this included evidence of the Greyhound Blooding in Australia. They were calling for evidence during the Bob Bentley investigation and racing Queensland. I delivered a Briefcase full of Evidence, evidence of corruption, including Audio, transcripts, and emails with no response. The evidence was later returned to my Post Office Box with no correspondence. NO REPLY
- 14. Show Cause Notice X 2- Current Attorney General Yvette D'Ath also got delivered a large amount of evidence including evidence of Race fixing, racing Queensland owning Greyhound trained under other names. Starting boxes being moved without consent to advantage the no 8 Dog. I have signed affidavits from Ipswich Board members, Audio, transcripts and Emails and evidence of my false set up. I had to push hard for a response and got the runaround again advising me to go to the Queensland Crimes and Conduct Commission. I had already tried them several times, where they had advised me they were not going to look into it again, they had never even looked into it previously.
- **15.** Andrew Wilkie also a large amount of evidence, delivered by registered mail delivered person to person including hard drives, audio, documents, emails with no response. **NO REPLY**
- 16. Crime and Misconduct Commission Queensland. They have had ample requests from Police and MPS from all states to look into these allegations for an investigation, again they replied that they were not going to look into it again but they have never looked into it. Question is it because Queensland Government is Racing Queensland only shareholder and they have a lot of Government connections? I have been told by Board Members of Racing Queensland that they are untouchable because of their connections with the Queensland Government.
- 17. Australia Crimes Commission in Canberra, boxes of evidence, including hard drive, audio, transcripts, documents. I actually drove to Canberra but was followed and then drove onto Melbourne and sent it from 4 different post offices by registered post. NO REPLY
- 18. RSPCA in Queensland 2008, I was working at the RSPCA paws walk in Bundaberg with Laurie Stageman an inspector for RSPCA in Brisbane. I also showed him the areas and places where the blooding and Animals being shot was happening. Laurie admitted to me (which I have a recording of) that there were people in RSPCA that were tipping off Danny Ryan and the Racing Board when there was a raid about to happen. He was then directed to stay away from me by his superiors, he told me it was because of the evidence I had.
- **19.** Animals Australia, came to my place in 2013 I showed them around in my Motorhome which was fully equipped with surveillance equipment to where the blooding's were taking place and Greyhounds being shot. Evidence of corruption and animals being blooded and Greyhounds being shot, was hand delivered in 2013 to Sarah at Melbourne Airport. (I have video evidence of the delivery) Once I mentioned Corruption on the board of Racing Queensland and Queensland Government they said it was too big and ran, performant means and with it.

- 20. Animals Liberation in Queensland they came to my place in 2013 also and we went through video and audio evidence proving Blooding of Greyhounds, Greyhound killing in NSW and Queensland and high level corruption in Racing Queensland. Once the corruption regarding Racing Queensland and Queensland Government was mentioned they ran and didn't want any more to do with it.
- 21. Beenleigh Magistrates Court of Queensland
- 22. Bundaberg Magistrates Court of Queensland.
- 23. Maroochydore District Court of Queensland.
- 24. Bundaberg police officer Helen Oliver at Bargara.

Federal Police Canberra, I was advised to go to my local police to have it investigated, where I had already been several times and no one wanted to look at my evidence, stating that it was too big and would open Pandora's Box and they didn't want anything to do with it because it involved the Government.

- 28. All senior Sargent's and fellow officers in Victoria Police received a letter and supporting documents of corruption, replies were stating it was a Criminal matter to be dealt with by The Queensland Attorney General and the Crimes Misconduct Commission and Queensland Government.
- 29. All senior Sergeants and fellow officers NSW Police Services replies were stating it was a Criminal matter to be dealt with by The Queensland Attorney General and the Crimes Misconduct Commission and Queensland Government.
- **30.** All senior Sergeants and fellow officers Queensland Police Services, very minimal response, the few responses stating to go to local police and Crimes Commission in Queensland to have it investigated.
- 31. Tony Abbott NO REPLY
- **32.** All MP's in Australia min replies stating again go to local police or the Crimes Commission in Queensland to have it investigated.
- 33. Every Senator in Canberra. NO REPLY
- **34.** All parliament offices in Australia. Minimal replies stating go to local police and Crimes Commission in Queensland to have it investigated.
- 35. Anna Bligh NO REPLY
- **36.** Health Minister Stephen Robertson in 2008 minimal reply wasn't interested and passed the buck and a complete run around.
- 37. Burpengary Police Station Acting Senior Sergeant Mark Spencer, had previously witnessed some of the incidents against me caused by Kerry Watson and her board so I am not sure if he ever received it, as I feel that he is an honest Police Officer and would have got back to me.
- **38.** Racing Queensland. (there was ample opportunity from 1999 then again from 2005 when the Chiropractor Board of Queensland and Kerry Watson (Chairperson of GRA Queensland now Racing Queensland) came together at the same time to destroy me and get me out of the industry, because of what I knew about the dark side of Racing Queensland and I was trying to get it cleaned up for the betterment of Racing Queensland for everyone, then again in 2007 when I was set up by the false inquiry and the Chiropractic Board of Queensland (now Chiropractic Board of Australia) tried to prosecute me for using the words Chiropractic, Chiropractor and Chiro, I won this case against me. All of this could have been stopped within house, the Greyhound Crimes, including Greyhound Blooding, and shooting of innocent Greyhounds but the opportunity was never taken.

- 44. Warwick Betts told me he was a friend of a friend of yours, and would be able to help me get the evidence to you. I have included evidence of this. He has now disappeared.

All of these organizations and more have FAILED in their professional capacity to act on a known and orchestrated injustice, and their Duty of Care, which effects not just me but is in the best interest of the Australian public. I have a petition actively running on Facebook to request a Royal Commission into the corruption within Government bodies in Queensland why my evidence was covered up.

The whole legal fraternity in Queensland is well aware of the corruption and colluding evidence I have on Racing Queensland, the Chiropractic Board of Australia and their Government Connections. There is not one Lawyer or Barrister in Queensland that will act on my behalf fearing that they will be black banned like I have been.

I have been fighting this battle for over 21 years and as you can see I have tried every avenue and without trying to do damage to any organizations, that was made clear during my correspondence and they have chosen to ignore the opportunities to deal with it in house and have laughed at me thinking I was a joke and would back down and go away.

Also you will find a true documentary of Corruption within Racing Queensland and Kerry Watson- Ned Snow All Documentary Doc Jamieson. Can be viewed at you tube, also proof of the ongoing knowledge of conspiracy, corruption and collusion within Racing Queensland.

I have had to post evidence on Facebook to protect my own life and to show proof that what I am saying is nothing but the absolute truth.

I have had people hand me evidence regarding Greyhound Racing Corruption and Race Rigging and they have later gone home to find that their dogs have been poisoned and they have said if there is a Royal Commission into Racing Queensland that they will come forward with more evidence. I am at the end of my road exhausting every avenue, I have no money, no work, no clinics, no life, and am constantly looking over my shoulder and no Greyhounds or Racing License.
