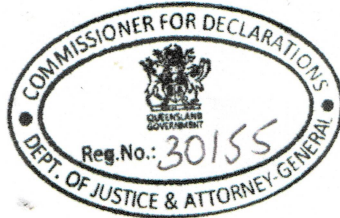

SHOW CAUSE NOTICE

Dear Jarrod Bleijie:

I am serving you a show cause notice in regard to:

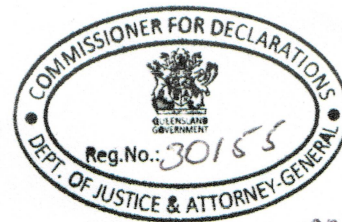
- Why did you not investigate the evidence that was hand delivered and signed for and recorded, to you on 17 October 2013 at State Law Building 50 Ann St. Brisbane and also at the Maroochydore office?
- Why have you covered up, hidden, lost Or dismissed this case, you sent back some of the evidence and information that I gave you in a bundle wrapped in brown paper with no name on the back just my address. I forwarded it onto the Australian Crimes Commission in Canberra.
- Just recently I have had another greyhound poisoned and another greyhound blinded by something being sprayed into their eyes, (this is the 2nd greyhound blinded) previously I have had 16 greyhounds and 1 cat poisoned to try to silence me. I have also had equipment damaged and a vehicle stolen, and over \$100,000 taken fraudulently from my bank account.
- Also in March 2014 I had been hospitalized due to being attacked/ ambushed, this was never investigated by the police. Previously I have had numerous death threats and attempts to silence me.
- I am seeking a Grand Jury Indictment for the corruption that has been placed forth upon me. I have now gone to the Victorian Police and MP's, Senators in Parliament in Canberra and Australian Crimes Commission in Canberra for help.
- My animal chiropractic business has been closed down because of all the misleading and corruption, collusion, fraudulent acts that has been covered up. These have taken place within my surroundings around my life. This has not been dealt with or looked into even for my safety or as a duty of care of an Australian Citizen.
- I have exhausted every possible avenue and have evidence to confirm this, and bring safety to the community and Justice against the conspiracy, colluding and false set up that started from Kerry Watson of Racing Qld.
- The main stream media was also issued with all the evidence of my case, this evidence was lost, misplaced or covered up and not dealt with at all.
- To my disappointment I have also sent a letter to Tony Abbot describing my situation and providing information of proof of evidence of corruption and conspiracy that I have in my possession, and copies spread around Australia. I have heard nothing from his department, no correspondence at all. There has been huge lack of duty of care to this situation. It appears to me that whilst I am concerned about holding up the enforcement of justice, the people whom are currently working for the cause of justice have shown me nothing more than a lack of interest for the cause of Justice, making way for more corruption and dishonesty to play a major role and take over our society.
- In 2006 Chief Steward Danny Ryan and investigating officer Darryl Kay came to my property at Willowvale and told me that Kerry Watson (she was a chairperson using her position as a tool) had been to the Chiropractic Board Of Qld to open an inquiry into me in 2007 at the same time as I was

going to court to defend my name against the Chiropractic Board, She was at the courthouse on that day trying to defame my name and character. She was doing this to me for a favor to the Thompsons, and because I knew about the inside corruption and collusion. I already knew about her trying to set me up hence my voicemail (attached) she had the opportunity then to stop all of this but she did not.

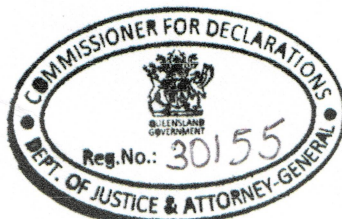
