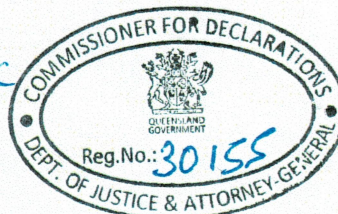
I am writing to follow up my previous correspondence to the Attorney General's office outlined above.

Your response to my letter dated 23 January 2015, written by James Sullivan Chief of Staff on behalf of the Honourable Yvette D'Ath discusses options for me to seek legal advice. I am not seeking legal advice, I am seeking action from you to uncover criminal activity within the Office of Racing, Racing Queensland, the Chiropractic Board of Queensland (now Chiropractic Board of Australia) and Stewards & Officials in Queensland Racing. I am also seeking an explanation as to why the Attorney General's office has not actioned the criminal evidence provided in October 2013. I have attached a photocopy of some of the evidence previously provided and Confirmation/Receipt of Delivery of evidence to Attorney General and QLD Racing Inquiry of Commission 22/10/13.

John Patterson from the Office of Racing is directly responsible for covering up evidence of the false allegations levelled against me by Kerry Watson, Danny Ryan and John Doss. Danny Ryan also brought it to my attention that Racing Queensland only has one shareholder, and that is the Queensland Government. He also stated that he, Kerry Watson and anyone else in the Greyhound Racing Authority is not worried about the CMC or any other investigating organisations because they have high level contacts within the CMC.
